ORDER

The Director, Scheduled Castes Development Department vide letter read 2nd above had furnished proposal for the construction of a Library Hall, Ladies Toilet and other works in Industrial Training Institute, Singarathope at an estimate cost of Rs.36,34,000/- for the approval of Departmental Working Group.

The Departmental Working Group meeting held on 02.03.2016 had approved the above proposal subject to condition that the work should be executed through Public Works Department subject to usual conditions and observance of Departmental Working Group instructions for construction projects stated under item No.1 of Departmental Working Group minutes read 2nd above.

Government have accepted the above decision of Departmental Working Group and are pleased to accord Administrative Sanction for the construction of Library Hall, Ladies Toilet and other works in Government I.T.I, Singarathope at an estimate cost of Rs.36,34,000/- (Thirty six lakhs and thirty four thousand), subject to condition that the work should be executed through Public Works Department, and subject to due observance of instructions of Departmental Working Group regarding construction works


