ORDER

As per the order read as first paper above, Government have accorded administrative sanction to Centre for Continuing Education, Kerala for conducting Diploma in Computer Application course to 1200 Scheduled Caste students during 2013-14. Now the Director, Scheduled Castes Development Department has submitted a proposal for conducting Diploma in Computer Application course benefiting 1200 Scheduled Caste students in various Arts and Science Colleges for enhancing their employability chances for the year 2014-15.

2. The Departmental Working Group held on 17.11.2014 considered the proposal and recommended to sanction the same subject to the condition that future batches will be sanctioned after proper evaluation of the programme outcomes (especially the performance relative to non-SC students)

3. Government accept the recommendation of the Departmental Working Group and are pleased to accord administrative sanction for conducting Diploma Course in Computer Application to 1200 Scheduled Caste students through Centre for Continuing Education, Kerala (CCEK) at an estimated cost of Rs.75.60 lakh (Rupees Seventy Five Lakhs and Sixty Thousand Only) as detailed below:


