ORDER

The Secretary, Palakkad Municipality has submitted a proposal through the Director, Scheduled Castes Development Department for sanctioning ₹3,67,00,000/- from the SC fund for constructing a flat for 64 Scheduled Caste families in Shankuvarathodu colony in Palakkad Municipality. Out of the total project cost of ₹720 lakhs (as per the estimate prepared by the Habitat Technology Group, Thodupuzha), the Municipality's share and that of Integrated Housing and Slum Development Programme (IHSDP) are respectively ₹172 lakhs and ₹181 lakhs and there is a shortage of ₹367 lakhs .

2. The Departmental Working Group held on 17-03-2015, considered the proposal and recommended to sanction an amount of ₹3,67,00,000/- subject to the following conditions :

- i) Memorandum of Understanding should be signed with the Palakkad Municipality
- ii) Formalities for selection of beneficiaries should be followed
- iii) The guidelines issued vide Government Order read above should strictly be followed.

3. Government accept the recommendation of the Departmental Working Group and are pleased to accord administrative sanction accordingly with the expenditure in this regard to the tune of ₹3,67,00,000/- (Three Crore, Sixty Seven lakhs only) to be met from the Head of Account "2225-01-800-57–Corpus Fund(Plan)" in the current year's budget.
