ORDER

Name of scheme / sub scheme : Implementation of PCR Act & POA Act – Cash incentive for inter caste marriage , POA Act implementation -50% Centrally Sponsored Scheme

Amount of administrative sanction : Rs.11.00 Crores(Rupees Eleven Crores).

3. The said continuing scheme / sub scheme will be implemented during 2015-16 strictly as per the approved parameters and subject to the following conditions :

- e) Tender / e-tender related instructions issued by Government of Kerala from time to time, wherever applicable would be duly observed.
- f) Expenditure on a particular item would be done as per delegated powers of Director, SCDD
- g) Proper inventory of items Procured / Assets Created wherever applicable, would be maintained.
- h) Due steps would be taken for the proper upkeep and maintenance of the items procured/ assets created.


4. The expenditure in this regard will be met from the Head of Account
