ORDER

The Director, Scheduled Castes Development Department has submitted a proposal for purchasing 100 computers for the use of various District Development Offices and Block SC Development offices at a cost of ₹40,000/- each with the total cost being ₹40,00,000/-(Rupees Forty Lakhs only). 2. The Departmental Working Group held on 14-01-2016, considered the proposal and recommended the purchase of computers for Directorate, District Development Offices and Block SC Development Offices, subject to the following conditions :

i) Only those computers will be considered for replacement which are :-

(a) atleast 3 years old

(b) have become obsolete, outdated and beyond repairs.

List of such computers will be certified by a committee chaired by the The Director, Scheduled Castes Development Department with a technical expert from National Informatics Centre or Information Technology Department and Finance Officer, SCDD as members alongwith any other members decided by the Director, SCDD.

ii) Number of new computers to be purchased will be restricted to the number of computers to be replaced as per the above condition and as certified by the Committee.

iii) The Stores Purchase Rules and other guidelines should be strictly adhered to.

3. Government accept the recommendation of the Departmental Working Group and are pleased to accord Administrative Sanction accordingly with the expenditure in this regard to be met from the Head of Account "2225-01-001-94-34(P)-Modernisation and e-governance initiatives in SC Development Department" in the current year's budget.
