ORDER

The Director, Scheduled Castes Development Department submitted a proposal for Rs.305.22 lakhs for the revamping and strengthening of 7 Model Residential Schools under Scheduled Castes Development Department before the Departmental Working Group.

2. The Departmental Working Group met on 2.3.2016 considered the proposal and recommended to approve the same in principle subject to the following conditions/observations.

a) Cost of smart class room in Punnappra MRS will be limited to about Rs. 6 to 8 lakhs on the lines of estimated cost for this item for Vellachal MRS & Kuzhalmannam MRS. This work will be executed through an expert agency through open competitive bidding process only, for all the selected MRS covered in the proposal together, in consultation with experts in the subject, duly observing Stores Purchase Rules & Government instructions issued by SCDD/IT/FD in this regard. The work would be coordinated, supervised and monitored by Director SCDD.

b) Furniture required for peerumedu MRS will be restricted to maximum Rs.10 lakhs, for Kuzhalmannam Rs.5 lakhs.

c) Cost estimates for library cum reading room in Punnappra MRS shall be reviewed and reworked as these are on a very high side. Similarly need for construction of higher secondary block and electrification and plumbing would be assessed by Director/JD SCDD by making a visit to MRS and got approved from Chariman of State SC&ST Residential Educational Society, work to be executed by State PWD subject to usual conditions.

d) Before purchasing Desktop Computer/Laptops,(and corresponding UPSs/accessories etc) the availability of existing Computers/Laptops will be rechecked and requirement of new Computers/Laptops shall be re/assessed to see whether these are for replacement of outdated,obsolete, non-repairable and old(minimum 5 years) or as additional requirement over and above existing number. This will be certified by a Committee chaired by Director, SCDD with JD (Education), FO SCDD and Principals/HM's of concerned MRSs as members. Based on report/certification of this Committee, Chaired by Director, SCDD, replacement for old (minimum 5 years) outdated, obsolete & non-repairable Desktop Computers/Laptops/related accessories can be done by the Director. Purchase of new Desktop Computer/Laptops as an additional requirement exceeding five, in any MRS would require fresh approval of DWG.
