ORDER

The Managing Director, Kerala State Development Corporation for Scheduled Castes/Scheduled Tribes Limited, Thrissur, in the letter read above has reported that in the State Budget for 2014-15. Government have provided an amount of ₹ 1042 lakh (1020+22) to the Kerala State Development Corporation for Scheduled Castes/Scheduled Tribes Limited, Thrissur, under the head of accounts " 4225-01-190-99 (SCP)" and "4225-02-190-99 (TSP) " towards Share Capital Contribution in the ratio of 49:51 for the share of Central & State Governments respectively.

2.The Managing Director has forwarded necessary proposal for the release of funds alongwith Economy Certificate, Utilization Certificate and has requested to release the State Share of ₹ 1042 lakhs to the Kerala State Development Corporation for Scheduled Castes/Scheduled Tribes Limited, Thrissur.

3. Government have examined the matter in detail and are pleased to sanction for the release of the 1st instalment of state share of ₹ 478 lakh (Rupees four hundred & Seventy eight lakhs only) under the head of account "4225-01-190-99(SCP) Plan" and ₹ 22 lakh (Twenty two lakhs only) under the head of account "4225-02-190-99(TSP)-Plan" for implementing various schemes subject to the following conditions :-

- (i) The funds are not parked in Banks/ Financial institutions other than treasuries.
- (ii) The instructions stipulated in circulars read above shall scrupulously be followed
- (iii) The Corporation shall furnish duly authenticated detailed component wise statement of expenditure, Utilization Certificate in form No.44, KFC and Economy Certificate while forwarding the proposal for further release.

- (iv) The amount shall be utilized during the current financial year itself and for the propose for which the same is sanctioned.
- (v) The Corporation should take urgent steps to complete the audited accounts in a time- bound manner

4. The Director Scheduled Caste Development Department, Thiruvananthapuram will draw & disburse an amount of ₹ 478 lakh (Rupees four hundred & Seventy eight lakhs only) under the head of account "4225-01-190-99(SCP) Plan" to the Managing Director, Kerala State Development Corporation for Scheduled Castes/Scheduled Tribes Limited, Thrissur.

5. The Director, Scheduled Tribe Development Department, will draw and disburse an amount of ₹ 22 lakh (Twenty two lakhs only) under the head of account "4225-02-190-99(TSP)-Plan" to the Managing Director, Kerala State Development Corporation for Scheduled Castes/Scheduled Tribes Limited, Thrissur,


