ORDER

As per the Government Order read as Ist paper above, Government have accorded Administrative Sanction for starting 29 Homeopathic Health Centre under Homeopathic Department in Scheduled Castes dominant areas by meeting the expenditure from Pooled Fund for SCP 2011-2012. Further as per G.O read as 2<sup>nd</sup> paper above fund was sanctioned from pooled fund for SCP 2013-2014 for the continuation of the above Health Centres, based on the proposal submitted by Director, Homeopathy Department. Now the Director, Scheduled Castes Development Department vide his letter read above has furnished a proposal submitted by Director, Homeopathy for allowing funds from pooled fund for SCP 2014-2015 for the continuation of the said 29 Homeopathic Health Centre in Schedules Castes Majority areas. The proposal was vetted by State Planning Board and offered the following remarks.

1. *The Components included in the proposal are honorarium to medical officers, Staffs, Medicine and other establishment charges for continuing the centres during 2014-2015. The running and recurring expenditure may be met from other source of fund of Scheduled Castes Development Department.*
2. *Schedules Castes Development Department should asses the present condition of the centres such as infrastructure facilities available, staff pattern, benefited SC people.*

Accordingly the Director, Scheduled Castes Development Department has recommended to sanction an amount of Rs. 206.48 Lakhs from the Corpus Fund for SCP 2014-2015, for meeting the expenditure for the continuation of the above 29 Health Centres.

:2:

The Departmental Working Group held on 17/11/2014 consider the proposal and after detailed examination , the meeting decided to sanction the proposal subject to the condition that:-

1. An interim report is obtained from District Development Officers that the Centres now existing are still in compliance with the terms of the original sanction orders.
2. The Directorate should take immediate action to Commission an evaluation study Criteria to be approved by Principal Secretary to Government within a month.

In the above circumstances sanction is accorded for the continuation of 29 Homeopathic Heath Centres in Scheduled Castes majority areas during the year at an estimate cost of Rs.2,06,48,000/- ( Two Crores Six Lakhs Fourty Eight Thousand Rupees Only) as decided by the Departmental Working Group on 17/11/2014.

The Expenditure in this regard will be met from the Head of Account 2225-01-800-57 Corpus Fund (Plan), from the Budget of Scheduled Castes Development Department for the year 2014-2015.
