ORDER

As per the letter read I above DSCDD has furnished a proposal for the benefit of 25 unemployed Scheduled Caste youths by offering hand on Training on Automobile repair and maintenance and giving guidance to establish Kerala Automobile Ltd authorized automobiles service stations with a total cost of Rs. 74.25 lakh. The prime objective of the scheme is to provide self employment schemes in the automobiles industries by starting automobile workshop, trained the Scheduled caste youth professionally in automobile sector and help them to establish Kerala Automobile Ltd authorized service centres. Kerala Automobile Ltd will provides technical support to the project.

The Project cost of the scheme is as detailed below.

Government accepts the recommendation of Departmental Working Group and sanction is hereby accorded for implementing the scheme at an estimated cost of Rs. 74.25 lakhs (Seventy Four lakhs Twenty Five thousand only) subject to the said condition prescribed by Departmental Working Group.

The expenditure in this regard will be met from the head of account 2225-01-102-96 (Plan) from the budget of Scheduled Caste Development Department for the year 2014-15.
