ORDER

The Director, Scheduled Castes Development Department vide his letter read above has submitted a proposal for self employment Scheme for 50 Scheduled Castes women in Palakkad, Malappuram, Kozhikkod, Wayanadu, Kannur, and Kasarkod Districts by vending of Milma Ice Cream through Canopy Vehicle fitted with charged UT Freeser at an estimate cost of Rs. 135 lakhs. Total cost per beneficiary for providing Ice Cream vending Machine fitted with charged UT freezer is Rs. 135 lakhs as detailed below;

The Departmental Working Group in its meeting on 11.02.2015 examined the proposal in detail and decided to give sanction for the project subject to the receipt of the the progress report on the MILMA canopy already sanctioned using some comparable criteria and the implementation of the scheme will follow similar process as done previous year.

In the Circumstances Administrative sanction is accorded on the basis of the said decision of the Departmental Working Group for self Employment Generation for the 50 Scheduled Castes women by vending of Milma Ice Cream through canopy vehicle fitted with charged UT freezer in Palakkad, Malappuram, Kozhikode, Wayanadu, Kannur, and Kasargod Districts at an estimated cost of Rs.1,35,00,000/- (Rupees One hundred and thirty five Lakh Only) , subject to the said condition prescribed by Departmental Working Group

The Expenditure in this regard will be met from the Head of Account 2225-01-793-99-(05) SCSP (plan) from the Budget of Scheduled Castes Development Department for the year 2014-2015.
