ORDER

The Director, Scheduled Castes Development Department has furnished a detailed project proposal in his letter read as first paper above for giving administrative sanction for certificate courses in “Cosmetology and Beauty Parlour Management”, benefitting Scheduled Castes students in various Government/Aided Arts and Science Colleges, Polytechnic Colleges and Vocational Higher Secondary Schools, with Centre for Continuing Education Kerala (CCEK) as the implementing agency. Also required technical expertise for the course will be provided by Institute of Fashion Technology, Kerala, Kollam (IFTK).

The Departmental Working Group held on 11.12.2014 considered the proposal and recommended to sanction the proposal with the following conditions:-

1. Detailed report should be submitted by the Director, Scheduled Castes Development Department, Thiruvananthapuram at the end of the course.

2. The scheduled Castes students intake will not be limited to reservation quota.

3. The involvement of District Officers , Scheduled Caste Development Department in monitoring the scheme should be ensured.

4 .The scheme sanctioned for maximum 200 students, over one batch limiting the expenditure upto 15 lakhs.

Government accepted the recommendation of the Departmental Working Group Meeting and are pleased to accord administrative sanction accordingly.

The expenditure in this regard for Rs. 15 lakh (Rupees Fifteen lakh) will be met from the Head of account "2225-01-102-96'Assistance for training &Employment(Plan) .


